DEED OF VARIATION TO THE FUNDING AGREEMENT

THIS DEED is made the 8th day of August 2018

BETWEEN

- 1) The Secretary of State for Education (the "Secretary of State"); and
- 2) The Teesside Learning Trust (the "Company") a charitable company incorporated in England and Wales with registered number 07185357, together, the "Parties".

INTRODUCTION

- A. The Parties entered into a supplemental funding agreement dated on or about 7 April 2010, as subsequently varied by a deed of variation dated 30 August 2016 (the "Existing SFA") relating to the establishment, maintenance and funding of Freebrough Academy in accordance with the Existing SFA.
- B. The Parties now wish to vary and amend certain terms and conditions of the Existing SFA in accordance with the terms of this Deed.
- C. This Deed is supplemental to the Existing SFA.

1. INTERPRETATION

- 1.1 Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the Existing SFA.

2. VARIATION OF THE FUNDING AGREEMENT

- 2.1 The Parties agree that with effect from 1 September 2018 the Existing SFA shall be amended as follows:-

Capacity Number: 1000

Age Range: 11-16

Number of Sixth Form places: Nil

Clause 2B shall be amended as follows: The planned capacity of the Academy is 1000 in the age range 11-16. The Academy will be an all ability inclusive school

- 2.2 Except as varied by this Deed, the Existing SFA shall remain in full force and effect.

3. Governing law and jurisdiction

- 3.1 This Deed, and any disputes or claims arising out of or in connection with it, its subject matter or formation (including non-contractual disputes or claims), shall be governed by and construed in accordance with English law.

3.2 The parties irrevocably agree that the English courts have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter or formation (including non-contractual disputes or claims).

4. Counterparts

4.1 This Deed may be executed in any number of counterparts and by the parties to it on separate counterparts, each of which when so executed and delivered shall be an original, but all the counterparts shall together constitute one and the same instrument.
