DEED OF VARIATION TO THE FUNDING AGREEMENT

THIS DEED is made the 6th day of October 2017

BETWEEN

- 1) The Secretary of State for Education (the "**Secretary of State**"); and
- 2) Southend East Community Academy Trust, (the "**Academy Trust**") a charitable company incorporated in England and Wales with registered number 07825856, together, the "**Parties**".

INTRODUCTION

- A. The Parties entered into a supplemental funding agreement forming part of a deed of variation on 25 August 2016 (the "**Funding Agreement**") relating to the maintenance and funding of Shoeburyness High School (the "**Academy**").
- B. The Parties now wish to vary and amend certain terms and conditions of the Funding Agreement in accordance with the terms of this Deed.
- C. This Deed is supplemental to the Funding Agreement.

1. INTERPRETATION

- 1.1 Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the Funding Agreement.

2. VARIATION OF THE FUNDING AGREEMENT

- 2.1 The Parties agree that with effect from 31 August 2018 the Funding Agreement shall be amended as follows:

2.1.1 The summary sheet at page 4 of the Funding Agreement shall be deleted and replaced with the following summary sheet:

"The planned capacity of the Academy is 1841 in the age range 11-18, including a sixth form of 350 places. The Academy will be an all ability inclusive school."

2.2 Except as varied by this Deed, the Funding Agreement shall remain in full force and effect.

3. Governing law and jurisdiction

3.1 This Deed, and any disputes or claims arising out of or in connection with it, its subject matter or formation (including non-contractual disputes or claims), shall be governed by and construed in accordance with English law.

3.2 The parties irrevocably agree that the English courts have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter or formation (including non-contractual disputes or claims).

4. Counterparts

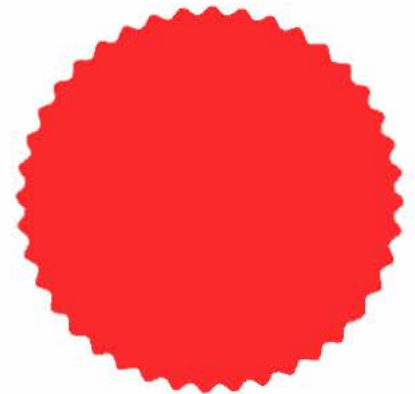
