## DEED OF VARIATION TO THE FUNDING AGREEMENT

THIS DEED is made the 26 day of November 2020

### BETWEEN

- 1) The Secretary of State for Education (the "**Secretary of State**"); and
- 2) **Quarrydale Academy** a charitable company incorporated in England and Wales with registered company number 07891230 whose registered address is Quarrydale Academy, Stoneyford Road, Sutton-In-Ashfield, NG17 2DU together, the "**Parties**".

### INTRODUCTION

- A. The Parties entered into a single funding agreement in respect of Quarrydale Academy dated on or about 31 January 2012 (the "**Funding Agreement**") relating to the establishment, maintenance and funding of an Academy in accordance with the Funding Agreement.
- B. The Parties now wish to vary and amend certain terms and conditions of the Funding Agreement in accordance with the terms of this Deed.
- C. This Deed is supplemental to the Funding Agreement.

### 1. INTERPRETATION

- 1.1 Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the Funding Agreement.

### 2. VARIATION OF THE FUNDING AGREEMENT

- 2.1 The Parties agree that with effect from 15 October 2020, the Funding Agreement shall be amended as follows:

- 2.1.1 Clause 17 of the Funding Agreement shall be deleted and replaced as follows:

- "17 The planned capacity of the Academy is 1,550 in the age range 11-18, including a sixth form of 110 places. The Academy will be an all ability inclusive school whose requirements for:
- a) the admission of pupils to the Academy are set out in Annex B to this Agreement;
  - b) the admission to the Academy of and support for pupils with SEN and with disabilities (for pupils who have and who do not have statements of SEN) are set out in Annex C to this agreement;
  - c) pupil exclusions are set out in Annex D to this Agreement.

2.2 Except as varied by this Deed, the Funding Agreement shall remain in full force and effect.

**3. Governing law and jurisdiction**

3.1 This Deed, and any disputes or claims arising out of or in connection with it, its subject matter or formation (including non-contractual disputes or claims), shall be governed by and construed in accordance with English law.

3.2 The parties irrevocably agree that the English courts have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter or formation (including non-contractual disputes or claims).

**4. Counterparts**

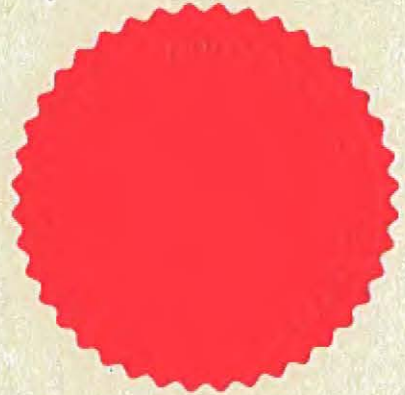
