**DEED OF VARIATION OF MASTER FUNDING AGREEMENT AND  
SUPPLEMENTAL FUNDING AGREEMENTS**

The Parties to this Deed are:

(1) **The Secretary of State for Education** of Sanctuary Buildings, Great Smith Street, London SW1P 3BT (the "**Secretary of State**");

- and -

(2) **REAch2WARWICKSHIRE ACADEMY TRUST**, a charitable company incorporated in England and Wales with registered company number 08269155 whose registered address is c/o Hillyfield Primary Academy, Higham Hill Road, London, E17 6ED (the "**Company**").

together referred to as the "**Parties**".

## **INTRODUCTION**

- A. The Parties have entered into a master funding agreement on 1 November 2012, a copy of which is contained in Schedule 1, (the "**Existing MFA**").
- B. The Parties have entered into a supplementary funding agreement in respect of the Oakfield Primary Academy on 1 November 2012, a copy of which is contained in Schedule 2 (the "**Existing Oakfield Primary Academy SFA**");
- C. The Parties have entered into a supplementary funding agreement in respect of Riverside Academy on 1 November 2012, a copy of which is contained in Schedule 3 (the "**Existing The Riverside Academy SFA**"); and
- D. The Parties have agreed to amend and re-state the terms of the Existing MFA, the Existing Oakfield Primary Academy SFA and the Existing Riverside Academy SFA, on the terms set out in this Deed.

## **LEGAL AGREEMENT**

- 1. Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the Amended Master Funding Agreement (as defined in clause 2 below).
- 2. The Secretary of State and the Company agree that with effect from the date of this Deed, the Existing MFA shall be amended and re-stated in the form of the Master Funding Agreement set out in Schedule 4 (the "**Amended Master Funding Agreement**"). For the avoidance of doubt, the Amended Master Funding Agreement does not terminate or suspend the Existing MFA but amends and re-states it.
- 3. The Secretary of State and the Company agree that with effect from the date of this Deed, the **Existing Oakfield Primary Academy SFA** shall be amended and re-stated in the form of the Amended Oakfield Primary Academy SFA set out in Schedule 5 (the "**Amended Oakfield Primary Academy SFA**"). For the avoidance of doubt, the Amended Oakfield Primary Academy SFA does not terminate or suspend the Existing Oakfield Primary Academy SFA but amends and re-states it.

4. The Secretary of State and the Company agree that with effect from the date of this Deed, the Existing Riverside Academy SFA shall be amended and re-stated in the form of the Amended Riverside SFA set out in Schedule 6 (the "**Amended Riverside Academy SFA**"). For the avoidance of doubt, the Amended Riverside Academy SFA does not terminate or suspend the Existing Riverside Academy SFA but amends and re-states it.

#### **GOVERNING LAW AND JURISDICTION**

3. This Deed, and any dispute or claim arising out of or in connection with it, its subject matter or formation (including non-contractual disputes or claims) shall be governed by and interpreted in accordance with the law of England and Wales.
4. The Parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim that arises out of, or in connection with, this deed or its subject matter or formation (including non-contractual disputes or claims).

#### **COUNTERPARTS**

5. This Deed may be executed in any number of counterparts and by the parties to it on separate counterparts, each of which when so executed and delivered shall be an original, but all the counterparts shall together constitute one and the same instrument.
