DEED OF TERMINATION OF MASTER FUNDING AGREEMENT

THIS DEED is dated the

27 day of August 2019

PARTIES

- (1) THE SECRETARY OF STATE FOR EDUCATION (the "Secretary of State"); and
- (2) SOUTH SHROPSHIRE ACADEMY TRUST a charitable company incorporated in England and Wales with registered number 08439425 c/o Church Stretton School, Shrewsbury Road, Church Stretton, Shropshire, SY6 6EX ("the Company")

together referred to as "the Parties".

BACKGROUND

- (A) The Parties entered into amaster funding agreement dated 26 March 2013 (the "Master Funding Agreement").
- (B) The Parties agree to terminate the Master Funding Agreement with effect from 00.01am on 1 September 2019 (the "Termination Date") on the terms set out in this deed of termination (the "deed").

AGREED TERMS

1. **DEFINITIONS**

In this deed, unless the context otherwise requires, expressions defined in the Master Funding Agreement and used in this deed shall have the meaning set out in the Master Funding Agreement. The rules of interpretation set out in the Master Funding Agreement apply to this deed.

2. TERMINATION OF THE MASTER FUNDING AGREEMENT

2.1 The Master Funding Agreement are terminated with effect from the Termination Date.

2.2 All provisions of the Master Funding Agreement, including any which are expressly stated in the Master Funding Agreement as surviving its termination, or which might otherwise have done so by implication, are terminated.

3. RELEASE AND WAIVER

Termination of the Master Funding Agreement shall not affect or prejudice any claim or demand that either party may have against the other under or in connection with the Master Funding Agreement arising before the Termination Date.

4. COUNTERPARTS

This deed may be executed in any number of counterparts, each of which when executed and delivered shall constitute a duplicate original, but all the counterparts shall together constitute the one deed.

5. GOVERNING LAW

This deed and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the law of England and Wales.

6. JURISDICTION

The parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this deed or its subject matter or formation (including non-contractual disputes or claims).
