(2) Aspirations Academies Trust a charitable company incorporated in England and Wales with registered number 07867577 ("the Company").

## INTRODUCTION

- A. The Parties entered into a Master Funding Agreement dated 1<sup>st</sup> July 2013.
- B. The Parties entered into a Supplemental Funding Agreement dated 22 August 2013 ("the Old SFA") relating to the establishment, maintenance and funding of an independent school known as Jewell Academy.
- C. The Parties now wish to vary and amend the terms of the Old SFA and wish to record their agreement as to such variations/amendments to the Funding Agreement by this Deed.

## LEGAL AGREEMENT

- 1. Any word or phrase used in this Deed shall, if that word or phrase is defined in the Funding Agreement, bear the meaning given to it in the Funding Agreement.
- 2. The Secretary of State and the Company agree that with effect from the date of this Deed the paragraph of the Old SFA as set out in Schedule 1 to this Deed shall be amended and restated in the form set out in Schedule 2 to this Deed.
- 3. As varied by this Deed, the Old SFA shall remain in full force and effect.
- 4. This Agreement shall be governed by and interpreted in accordance with English law.
