DEED OF VARIATION

The parties to this Deed are:

(1) The Secretary of State for Education ("the Secretary of State"),

- and –

(2) Leighton Academy a charitable company incorporated in England and Wales with registered number 8500778 ("the Academy").

INTRODUCTION

- A. The Parties entered into a funding agreement dated 1st June 2013 ("the Funding Agreement") relating to the establishment, maintenance and funding of an independent school known as Leighton Academy.
- B. The Parties now wish to vary and amend the terms of the Funding Agreement and wish to record their agreement as to such variations/amendments to the Funding Agreement by this Deed.

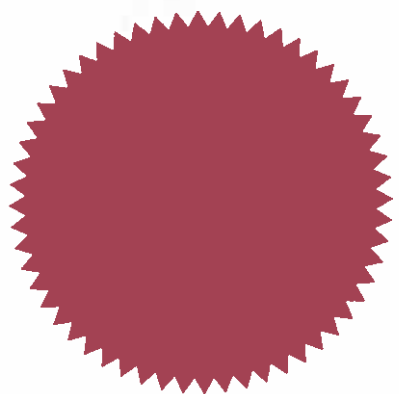
LEGAL AGREEMENT

- 3. As varied by this Deed, the Funding Agreement shall remain in full force and effect.

Schedule 1

Amendments to the Funding Agreement

1. Clause 17 of the Funding Agreement shall be replaced with:

17) The planned capacity of the academy is 485 in the age range 2 – 11, and a nursery unit of 120. The Academy will be an all inclusive ability school whose requirements for :

- a) the admission of pupils to the Academy are set out in Annex B to this Agreement;
- b) the admission to the Academy of and support for pupils with SEN and with disabilities (for pupils who have and who do not have statements of SEN) are set out in Annex C to this Agreement;
- c) pupil exclusions are set out in regulations made by virtue of section 51A of the Education Act 2002 (as may be amended from time to time, and includes any successor provisions).
