(1) The Secretary of State for Education ("the Secretary of State"),

(2) Greenwood Academies Trust, a charitable company incorporated in England and Wales with registered number 06864339 ("the Academy Trust")

together referred to as the "Parties"

INTRODUCTION


- A. The Parties entered into a supplemental funding agreement dated 23 December 2013 which was amended pursuant to a deed of variation dated 29 August 2014 ("the Funding Agreement") relating to the establishment, maintenance and funding of an independent school known as Green Oaks Primary Academy ("the Academy").
- B. Further to the Secretary of State's approval to close the designated special provision unit at the Academy (given on 24 June 2016), the Parties now wish to vary and amend the terms of the Funding Agreement and wish to record their agreement as to such variations/amendments to the Funding Agreement by this Deed.

LEGAL AGREEMENT

1. Any word or phrase used in this Deed shall, if that word or phrase is defined in the Funding Agreement, bear the meaning given to it in the Funding Agreement.
2. The Secretary of State and the Academy Trust agree that with effect from the date of this Deed the Funding Agreement shall be amended in accordance with Schedule 1 to this Deed.
3. As varied by this Deed, the Funding Agreement shall remain in full force and effect.


