## DEED OF VARIATION

The parties to this Deed are:

(1) The Secretary of State for Education (“the Secretary of State”),

- and -

(2) Greenwood Academies Trust a charitable company incorporated in England and Wales with company number 06864339 (“the Company”).

together referred to as the “Parties”.

### INTRODUCTION

- A. The Parties entered into a master funding agreement dated 27 March 2013 (“the Funding Agreement”) relating to the establishment, maintenance and funding of academies operated by the Company.
- B. The Parties now wish to vary and amend the terms of the Funding Agreement and wish to record their agreement as to such variations/amendments to the Funding Agreement by this Deed.

### LEGAL AGREEMENT

- 1. Any word or phrase used in this Deed shall, if that word or phrase is defined in the Funding Agreement, bear the meaning given to it in the Funding Agreement.
- 2. The Secretary of State and the Company agree that with effect from the date of this Deed the Funding Agreement shall be amended in accordance with Schedule 1 to this Deed.
- 3. As varied by this Deed, the Funding Agreement shall remain in full force and effect.





## Schedule 1

### Amendments to the Funding Agreement

1. The following definition shall be inserted at clause 6 of the Funding Agreement after the definition of "persons":

"PFI Academy" means an Academy which forms part of a scheme procured pursuant to the Government's Private Finance Initiative;"

2. At clause 65 of the Funding Agreement, the words "Not used" shall be deleted and replaced with the following:

*Subject always to clause 73, the Company shall, in relation to each PFI Academy, establish and maintain separate bank accounts to be used solely in respect of any monies provided by the Secretary of State pursuant to this Agreement for that PFI Academy. Monies provided by the Secretary of State will be paid into such accounts and will remain in those accounts until required. The Company agrees that such monies will be applied in accordance with the requirements of this Agreement*

3. A new clause 66A shall be inserted after clause 66 as follows:

*66A) Without prejudice to clause 66, the Company shall ensure that it has and continues to have sufficient capacity and expertise to manage the finances of all academies within the federation. The Company shall ensure that any funding which relates to the PFI Academy shall be accounted for separately.*

4. A new clause 89A shall be inserted after clause 89 as follows:

*89A) In complying with clauses 66 - 89 (inclusive), the Company shall (where relevant) be obliged to provide information which relates to each PFI Academy in addition to information which relates to the Company and any combined information which relates to all of the Academies that the Company operates.*
