(1) The Secretary of State for Education ("the Secretary of State"),

- and –

(2) Leigh Trust, a charitable company incorporated in England and Wales with registered number 08779660 ("the Academy Trust").

together referred to as the "Parties"

INTRODUCTION

- A. The Parties entered into a funding agreement dated 30 December 2013 ("the Funding Agreement") relating to the establishment, maintenance and funding of an Academy known as Leigh Primary School in accordance with the Funding Agreement.
- B. The Parties now wish to vary and amend the terms of the Funding Agreement and wish to record their agreement as to such variations/amendments to the Funding Agreement by this Deed.

- 1. Any word or phrase used in this Deed shall, if that word or phrase is defined in the Funding Agreement, bear the meaning given to it in the Funding Agreement.
- 2. The Parties agree that with effect from the date of this Deed the Funding Agreement shall be amended in accordance with Schedule 1 to this Deed.
- 3. As varied by this Deed, the Funding Agreement shall remain in full force and effect.

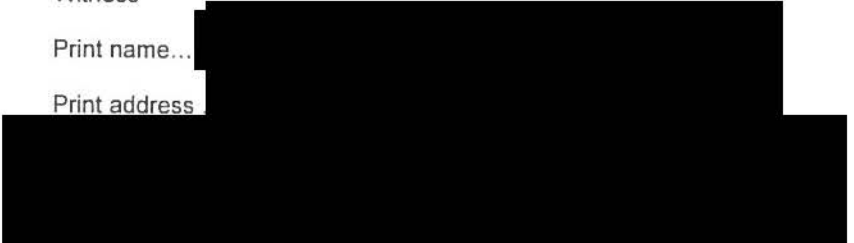
