**DEED OF VARIATION
relating to Two Supplemental Funding
Agreements dated 28 November 2014**

THIS DEED OF VARIATION is made on

19 November

2015

BETWEEN:

- (1) The Secretary of State for Education ("**Secretary of State**"); and
- (2) Saffron Academy Trust, a charitable company incorporated in England and Wales with registered number 07618351 ("**Company**")

together referred to as the "Parties".

INTRODUCTION:

- (A) The Parties entered into a Deed of Variation of Funding Agreement dated 28 November 2014 ("**Deed of Variation**") which varied the Existing Saffron Walden Master Funding Agreement and the Existing Alec Hunter Master Funding Agreement (as defined in the Deed of Variation).
- (B) The Parties entered into a Supplemental Funding Agreement dated 28 November 2014 ("**Existing Katherine Semar Infants School SFA**") relating to the establishment, maintenance and funding of a school known as Katherine Semar Infants School.
- (C) The Parties entered into a Supplemental Funding Agreement dated 28 November 2014 ("**Existing Katherine Semar Junior School SFA**") relating to the establishment, maintenance and funding of a school known as Katherine Semar Junior School.
- (D) The Parties now wish to vary and amend the terms of the Existing Katherine Semar Infants School SFA and the Existing Katherine Semar Junior School SFA and wish to record their agreement as to such variations/amendments by this Deed.

IT IS AGREED as follows:

1. The Secretary of State and the Company agree that with effect from the date of this Deed the paragraphs of the Existing Katherine Semar Infants School SFA as set out at Schedule 1 to the Deed shall be amended and restated in the form set out at Schedule 2 to this Deed.
2. The Secretary of State and the Company agree that with effect from the date of this Deed the paragraphs of the Existing Katherine Semar Junior School SFA as set out

at Schedule 3 to the Deed shall be amended and restated in the form set out at Schedule 4 to this Deed.

3. As varied by this Deed, the Existing Katherine Semar Infants School SFA and the Existing Katherine Semar Junior School SFA shall remain in full force and effect.
4. This Agreement shall be governed by and interpreted in accordance with English law.

This document has been executed and delivered as a Deed on the date stated at the beginning of this Deed.
