## **DEED OF VARIATION**

(2) Swale Academies Trust a charitable company incorporated in England and Wales with registered number 07344732 ("the Academy").

### **INTRODUCTION**

- A. The Parties entered into a supplemental funding agreement dated 30 January 2015 ("the Supplemental Funding Agreement") relating to the establishment, maintenance and funding of an independent school known as South Borough Primary School.
- B. The Parties now wish to vary and amend the terms of the Supplemental Funding Agreement and wish to record their agreement as to such variations/amendments to the Supplemental Funding Agreement by this Deed.

### **LEGAL AGREEMENT**

1. Any word or phrase used in this Deed shall, if that word or phrase is defined in the Supplemental Funding Agreement, bear the meaning given to it in the Supplemental Funding Agreement.
2. The Secretary of State and the Academy agree that with effect from the date of this Deed the Supplemental Funding Agreement shall be amended in accordance with Schedule 1 to this Deed.
3. As varied by this Deed, the Supplemental Funding Agreement shall remain in full force and effect.

## **Schedule 1**

### **Amendments to the Supplemental Funding Agreement**

1. Clause 2.5 of the Supplemental Funding Agreement shall be replaced with the following new clause 2.5:

The planned capacity of the Academy is 420 in the age range 3 to 11, including nursery places. The Academy will be an all ability inclusive school.
