DEED OF VARIATION TO THE FUNDING AGREEMENT**

THIS DEED is made the 10 day of August 2017

**BETWEEN**

- 1) The Secretary of State for Education (the "**Secretary of State**"); and
- 2) The Diocese of Chelmsford Vine Schools Trust, (the "**Company**") a charitable company incorporated in England and Wales with registered number 08709542 which has its registered office at 53 New Street, Chelmsford, CM1 1AT, together, the "**Parties**".

**INTRODUCTION**

- A. The Parties entered into a funding agreement dated on 30th January 2015 (the "**Funding Agreement**") relating to the establishment, maintenance and funding of an Academy called Mistley Church of England Primary School in accordance with the Funding Agreement.
- B. The Parties now wish to vary and amend certain terms and conditions of the Funding Agreement in accordance with the terms of this Deed.
- C. This Deed is supplemental to the Funding Agreement.

**1. INTERPRETATION**

- 1.1 Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the Funding Agreement.

**2. VARIATION OF THE FUNDING AGREEMENT**

- 2.1 The Parties agree that with effect from the date of this Deed the Funding Agreement shall be amended as follows:

In clause 2B and the Summary Sheet the age range will be 2-11 instead of 5-11.

- 2.2 Except as varied by this Deed, the Funding Agreement shall remain in full force and effect.

**3. Governing law and jurisdiction**

- 3.1 This Deed, and any disputes or claims arising out of or in connection with it, its subject matter or formation (including non-contractual disputes or claims), shall be governed by and construed in accordance with English law.
- 3.2 The parties irrevocably agree that the English courts have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter or formation (including non-contractual disputes or claims).

**4. Counterparts**

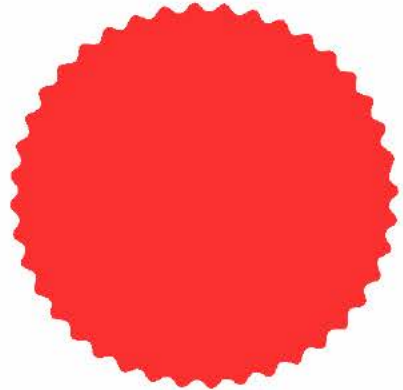
