## DEED OF VARIATION TO THE SUPPLEMENTAL FUNDING AGREEMENT

THIS DEED is made the 28 day of March 2017

### BETWEEN

- 1) The Secretary of State for Education (the "Secretary of State"); and
- 2) The Pax Christi Catholic Partnership, (the "Company") a charitable company incorporated in England and Wales with registered number 09378390, together, the "Parties".

### INTRODUCTION

- A. The Parties entered into a supplemental funding agreement dated on or about 1 March 2015 (the "Supplemental Funding Agreement") relating to the establishment, maintenance and funding of St Paul's Catholic Academy in accordance with the Supplemental Funding Agreement.
- B. The Parties now wish to vary and amend certain terms and conditions of the Supplemental Funding Agreement in accordance with the terms of this Deed.
- C. This Deed is supplemental to the Supplemental Funding Agreement.

### 1. INTERPRETATION

Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the Supplemental Funding Agreement.

### 2. VARIATION OF THE SUPPLEMENTAL FUNDING AGREEMENT

- 2.1 The Parties agree that with effect from the date of this Deed the Supplemental Funding Agreement shall be amended as follows:

- a) Summary sheet The entire summary sheet on page 4 is deleted and replaced with:

- b) **Clause 2.B** This clause is amended to read as follows: "The planned capacity of the Academy is 150 in the age range of 4 – 11 years old. The Academy will be an all ability inclusive school.

2.2 Except as varied by this Deed, the Supplemental Funding Agreement shall remain in full force and effect.

**3. Governing law and jurisdiction**

3.1 This Deed, and any disputes or claims arising out of or in connection with it, its subject matter or formation (including non-contractual disputes or claims), shall be governed by and construed in accordance with English law.

3.2 The parties irrevocably agree that the English courts have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter or formation (including non-contractual disputes or claims).

**4. Counterparts**

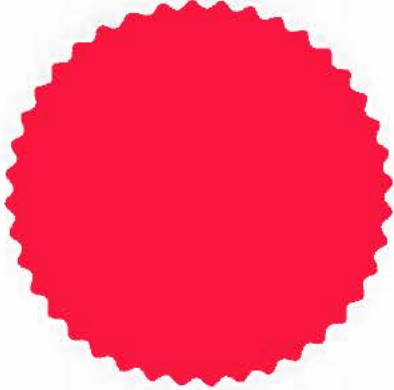

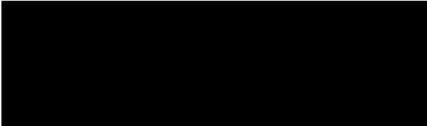
