**DEED OF VARIATION TO THE SUPPLEMENTAL FUNDING AGREEMENT  
FOR  
POLAM HALL SCHOOL**

THIS DEED is made the <sup>18<sup>th</sup></sup> day of June 2019

## BETWEEN

- 1) The Secretary of State for Education (the "**Secretary of State**"); and
  - 2) Woodard Academies Trust, a charitable company incorporated in England and Wales with registered number 06415729 (the "**Company**")
- together, the "**Parties**".

## INTRODUCTION

- A. The Parties entered into a supplemental funding agreement dated on or about 30 March 2017 (the "**Supplemental Funding Agreement**") relating to the establishment, maintenance and funding of Polam Hall School (the "**Academy**") in accordance with the Supplemental Funding Agreement.
- B. The Parties now wish to vary and amend certain terms and conditions of the Supplemental Funding Agreement in accordance with the terms of this Deed.
- C. This Deed is supplemental to the Supplemental Funding Agreement.

## 1. INTERPRETATION

Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the Supplemental Funding Agreement.

## 2. VARIATION OF THE FUNDING AGREEMENT

- 2.1 The Parties agree that with effect from 1 September 2020 the Supplemental Funding Agreement shall be amended as follows:

2.1.1 The Summary Sheet is varied to read as follows:

"Age range: 4-16"

"Number of sixth form places: N/A"

2.1.2 Clause 2.B is varied to read as follows:

"The planned capacity of the Academy is 882 in the age range 4 – 16, including 60 boarding places. The Academy will be an all ability inclusive school."

- 2.2 Except as varied by this Deed, the Supplemental Funding Agreement shall remain in full force and effect.

## 3. Governing law and jurisdiction

- 3.1 This Deed, and any disputes or claims arising out of or in connection with it,

its subject matter or formation (including non-contractual disputes or claims), shall be governed by and construed in accordance with English law.

3.2 The parties irrevocably agree that the English courts have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter or formation (including non-contractual disputes or claims).

**4. Counterparts**

This Deed may be executed in any number of counterparts and by the parties to it on separate counterparts, each of which when so executed and delivered shall be an original, but all the counterparts shall together constitute one and the same instrument.
