DEED OF VARIATION TO THE FUNDING AGREEMENT

THIS DEED is made the 3rd day of December 2018

BETWEEN

- 1) The Secretary of State for Education (the "**Secretary of State**"); and
- 2) The Stranton Academy Trust, (the "**Company**") a charitable company incorporated in England and Wales with registered number 08561049, together, the "**Parties**".

INTRODUCTION

- A. The Parties entered into a supplemental funding agreement dated 19 September 2016 (the "**SFA**") relating to the establishment, maintenance and funding of Jesmond Gardens Primary School (the "**Academy**") in accordance with the SFA.
- B. The Parties now wish to vary and amend certain terms and conditions of the SFA in accordance with the terms of this Deed.
- C. This Deed is supplemental to the SFA.

1. INTERPRETATION

- 1.1 Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the SFA.

2. VARIATION OF THE FUNDING AGREEMENT

- 2.1 The Parties agree that with effect from the date of this Deed the SFA shall be amended as follows:

2.1.1 Page 4, Summary Sheet is varied to read as follows:

"Capacity number: 315 plus 26 FTE nursery places, plus 16 FTE places for two year olds"

"Age Range: 2-11"

2.1.2 Clause 2.B is varied to read as follows:

"The planned capacity of the Academy is 315 plus 26 FTE nursery places, plus 16 FTE places for two year olds. The age range is 2-11. The Academy will be an all ability inclusive school."

- 2.2 Except as varied by this Deed, the SFA shall remain in full force and effect.

3. Governing law and jurisdiction

- 3.1 This Deed, and any disputes or claims arising out of or in connection with it,

its subject matter or formation (including non-contractual disputes or claims), shall be governed by and construed in accordance with English law.

3.2 The parties irrevocably agree that the English courts have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter or formation (including non-contractual disputes or claims).

4. Counterparts

4.1 This Deed may be executed in any number of counterparts and by the parties to it on separate counterparts, each of which when so executed and delivered shall be an original, but all the counterparts shall together constitute one and the same instrument.
