**DEED OF VARIATION TO THE FUNDING AGREEMENT**

THIS DEED is made the day of 25<sup>th</sup> August 2020

**BETWEEN**

- 1) The Secretary of State for Education (the “**Secretary of State**”); and
- 2) Prosper Learning Trust (the “**Company**”) a charitable company incorporated in England and Wales with registered number 11018923, together, the “**Parties**”.

**INTRODUCTION**

- A. The Parties entered into a supplemental funding agreement dated on or about 26 March 2019 (the “**Funding Agreement**”) relating to the establishment, maintenance and funding of Thomas Bewick School (the “**Academy**”) in accordance with the Funding Agreement.
- B. The Parties now wish to vary and amend certain terms and conditions of the Funding Agreement in accordance with the terms of this Deed.
- C. This Deed is supplemental to the Funding Agreement.

**1. INTERPRETATION**

- 1.1 Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the Funding Agreement.

**2. VARIATION OF THE FUNDING AGREEMENT**

- 2.1 The Parties agree that with effect from 1 September 2020 the Funding Agreement shall be amended as follows:
  - a) The planned number of places detailed in the table on page 4 of the Funding Agreement be replaced with the following text:

“251”
  - b) Clause 2.C be replaced with the following text:

“The planned number of places at the Academy is 251 in the age range 3 to 19.”
- 2.2 Except as varied by this Deed, the Funding Agreement shall remain in full force and effect.

**3. Governing law and jurisdiction**

- 3.1 This Deed, and any disputes or claims arising out of or in connection with it, its subject matter or formation (including non-contractual disputes or claims), shall be governed by and construed in accordance with English law.

3.2 The parties irrevocably agree that the English courts have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter or formation (including non-contractual disputes or claims).

**4. Counterparts**

4.1 This Deed may be executed in any number of counterparts and by the parties to it on separate counterparts, each of which when so executed and delivered shall be an original, but all the counterparts shall together constitute one and the same instrument.

**IN WITNESS** whereof this Deed has been executed by the parties hereto and is intended to be and is hereby delivered on the date first above written.

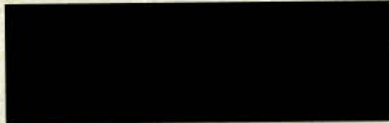
